## **Functions of the Quality Assurance Unit:-**

- 1-Setting the vision and mission of the unit, its strategic goals and operational plans, and documenting them by the college council.
- 2-Establishing the organizational and administrative structure of the unit and documenting it by the college council.
- 3-Activating the internal quality assurance system in the college to include academic and non-academic activities and documenting it with the college council.
- 4-Establishing mechanisms to activate the internal review of academic and nonacademic activities in the college with coordination and documentation of the various departments College Council.
- 5-Supporting and following up the college administration in setting the vision and mission of the college, and its strategic goals, and disseminating them widely in the college.
- 6-Provide workshops based on the training needs of faculty members to introduce the formulation and implementation of quality requirements such as Description and report of programs and courses and the use of modern systems in education, evaluation and others.
- 7-Ensure that the educational outcomes achieve the college's mission and thus achieve the university's mission and strategic goals with commitment With the required forms and the time specified for them.
- 8-Follow-up and review of the annual reports of the college's self-evaluation and its compliance with the required forms and the timeliness specified for them.
- 9-Establishing a mechanism to activate student participation (undergraduate and postgraduate students) in the unit's activities.
- 10-Spreading the culture of quality at the level of students, faculty, and administrators.







- 11-Study the training needs of faculty members and administrators and develop training plans with specialists from inside or outside College and university to develop their capabilities.
- 12-Following up on the nomination of the external evaluator for study programs, reviewing his reports and evaluating the extent of this on the educational process.
- 13-Follow-up of quality assurance projects in the college.
- 14-Discussing quality issues in the faculty council, main committees and department boards.
- 15-Strengthening the relationship with the University's Quality Assurance Center.

  16-Submit an annual report on the unit's activities to the Quality Assurance Center at Tanta University.
